Overall poll results

- 17 WELMEC members
- 5 Corresponding Organisations: AQUA, Farecogaz, CECIP, CECOD and ESMIG
- 16 Other (mainly experts)
- 38 Responses (!)



General interpretation of poll results

- Time constraints make a thorough assessment of the content of the proposals tough, not to mention the possible impact of the proposals (impact assessment)
- Poll responses are influenced by general opinions (process related): no changes to MID at all; no changes without an impact assessment; comments not taken onboard
- Neutral/I don't know/abstain: available but not reported
- Agree and disagree are purely indicative
- Alternative proposals only available shortly before the meeting



- view 1: certify meter only, including correction of cable losses: support*: CH, FI, NO, HU, SE
- view 2: certify measuring system, while allowing practical cable exchange solutions in the in use phase: support*: DE, NL, CZ, FR, AT, ES, TR, ChargeUp, FORCE

Concluding remarks (1)

- For some of the changes an impact assessment may be necessary. The European Commission is advised to take this into consideration.
- Consistency in terminology and impact on other parts of the Directive will be dealt with by the European Commission in the drafting of the amendment.
- The results of the poll are purely indicative and do not preclude any official comments in the legislative procedure once it is started by the European Commission.



Concluding remarks (2)

- Different views on EVSE/Annex V within WELMEC make it difficult to proceed towards consensus.
- A lot of basic material is available: core Annex V (DG), transfer point Annex V (NL), alternative approach Annex V (CZ/CMI)
- Directions may help the process
- No retrofitting needed (national responsibility)
- Optionality clause (article 3) will remain valid
