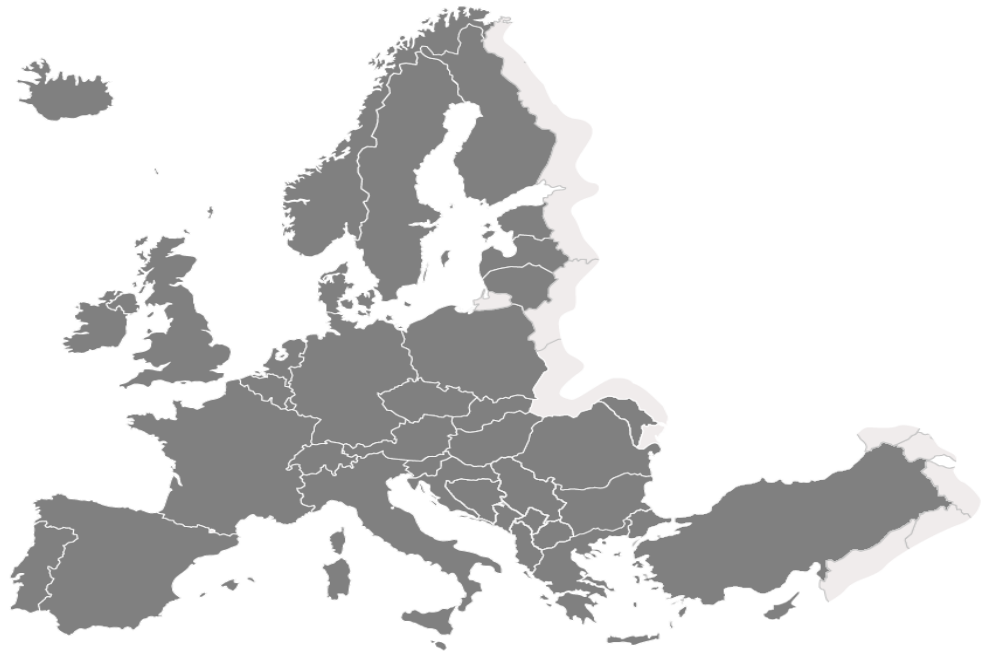

## Notes

1. The column “Comments” indicates, if necessary, the relevant text of OIML R106-1:2011 and related explanations concerning the compliance with the relevant requirements of Directive 2014/32/EU.
2. The column “Conclusion” gives the conclusion on the compliance between OIML R 106-1:2011 and the relevant requirements of Directive 2014/32/EU.

The indication “Covered” means that:

- the requirement of OIML R 106-1:2011 is identical to the one of Directive 2014/32/EU, or
- the requirement of OIML R 106-1:2011 is more severe than the one of Directive 2014/32/EU, or
- all the requirements of OIML R 106-1:2011 fulfil the requirements of Directive 2014/32/EU (even when Directive 2014/32/EU allows other alternatives),
- The indication “Partially covered” means that the requirement is not fully covered or R 106 allows possibilities which are not foreseen in the directive.

The indication “Not Covered” means that the requirement in Directive 2014/32/EU is either not compatible with the relevant OIML R 106-1 requirement or not included in OIML R 106-1.

The indication “Not Relevant” means that the requirement in Annex I of Directive 2014/32/EU is not relevant for automatic rail-weighbridges.

The text in *italic* is an extract from the relevant clause of the OIML Recommendation.
